EXTENDED DATE TO THE NATIONAL WAIVER TO ALLOW MEAL PATTERN FLEXIBILITY

UPDATE: On April 21, 2020, the U.S. Department of Agriculture (USDA) extended the effective date of the national waiver to allow **meal pattern flexibility** from April 30, 2020 to May 31, 2020. Providers should make every effort to meet the meal pattern requirements. Waivers are reviewed on a case-by-case and are for **existing** disruption.

The USDA and the California Department of Education (CDE) encourage providers to meet the nutrition standards of the Child and Adult Care Food Program to the greatest extent possible; however, we are aware that providers may experience shortages in the availability of some food and beverage items that contribute to a reimbursable meal. For example, providers are required to provide whole grain-rich foods and may have difficulty obtaining them due to shortages during this emergency.
