ACTION REQUIRED FOR PROVIDERS CLAIMING THEIR OWN CHILDREN (DUE AUGUST 23, 2024)

This is a reminder that next month, providers currently claiming or wanting to start to claim their own/foster children or residential children will need to complete a Meal Benefit Form for us to determine if their own children/foster or residential children will qualify for 2024-2025, based on their household income.

Meal benefit forms are required for providers who:

- Want to claim/continue to claim their own children (biological/adopted) or residential children (children that live in the provider's residence).

- Want to claim their foster child(ren), who live in the provider's residence . Foster children require to have their own meal benefit form (one form per foster child).


For those providers who fall in the categories listed above, the Meal Benefit Form needs to be updated in the month of August. The Meal Benefit Form is due by no later than Friday, August 23, 2024.

The Meal Benefit Form will be emailed to providers currently claiming children in the categories listed above.



URGENT REMINDER IF YOU HAVE SCHOOL AGE CHILDREN

With summer break here and school age children not attending school, please ensure to report the school out days on KidKare. In order to receive credit for school age children's AM Snack and Lunch meals, you need to log in the school out dates on the child's calendar before the current month ends. To do so click on **Calendar** on the side tool bar> On the top section, select the **Child** calendar> Then click on the drop down menu to select the **name of the child** you wish to access >Drag the **NO SCHOOL** box to the applicable dates in which the child did not attend school. If you make a mistake, simply click on the date and select delete
