Our Approved Processed Food's List has been updated. Please ensure to visit our website under the Policies & Regulations Tab to access the list. We do not recommend saving the list to your devices, as the list will continue to be updated. Instead, visit our website and click on the Approved Process Foods List, so you always access the most updated list.

Ensure to go over the list and serve the amounts listed, as some amounts were updated once we obtained the updated product formulation statements from the manufactures. The amounts shown are only the minimum amounts, you may offer the children more.

Manufactures may have the same item, but in different sizes/weight. For instance, a manufacture that is on the list, Foster Farms, has jumbo and regular size corn dogs and the serving requirements are different.

You will also notice a few items were removed and are no longer available on the KidKare food list. Some of the items removed are: Dutch Farm's Chicken Nuggets, Fast Fixin' Dino Bites, Hillshire Farm Club Sandwich Variety Pack, Kirkland Italian Meat Balls, and the **Crunchy** Van De Kamps Fish Fillets.

Van De Kamps Fish Fillets- We added a reminder for the Van De Camp Fish Fillets on the Approved Processed Foods List. The manufacturer informed us that they are unable to provide a product formulation statement for the Crunchy Fish Fillets. We only received a product formulation statement for the Crispy type.





If you have a food on the list that has a different UPC code, please email us a picture of the of the box/ bag that includes all sides, entire front label, nutrition facts label and UPC Code. Our agency will contact the manufacture to obtain a product formulation statement for that product.
